 Queen ~~do~~ doo present That Margarett -
 Scott of Rowdy - In the County of Essex
~~did~~ ~~do~~ About the latter end of July or the
 beginning of August - In the year aforesaid
 and divers other days and times as 1000 before as after
 certain detestable acts called Witchcraft and Sorceries
 wickedly maliciously and feloniously hath used
 practised and exercised Et and in the Town of
 Rowdy in the County of Essex aforesaid in upon and
 against one Mary Darnell of Rowdy -
 aforesaid single Woman -
 by which said wicked acts the said Mary Darnell hath
 aforesaid and divers other days and times both before and
 after year and is tortured afflicted punished Pinced Whipped
 and Cormented and also for sundry acts of Witchcraft
 by the said Margarett ~~of~~ ^{the Town of} Rowdy committed and done before and
 since that time against our Hon^{or} Lord & Lady the King
 and Queen their Honor and Dignity and the forme
 of the Statute in that case made and Provided.
